DBA, Skip Fordyce Harley-Davidson Buell, all Event vendors and all their parents, subsidiaries, members, shareholders, officers, directors, agents, sponsors, trustees, receivers, successors, beneficiaries, and assigns ("Indemnitees"), shall assume no liability or responsibility for personal injury, property damage, theft, damage, loss or any other claims that may occur or have occurred while Participant is participating in the Event and Participant agrees to hold Indemnitees harmless from and against, and reimburse them for, all claims, damages, costs and expenses, including, without limitation, interest, penalties, court costs and reasonable attorneys' fees and expenses, resulting from any such claims.

**Compliance.** All participants in activities at the Event, including but not limited to taking the vehicles on the track, must be 18 years of age and must provide a valid driver's license, proof of registration and insurance of their vehicle before taking part in any track or cruise activity. Participant agrees to drive within the speed range instructed and shall not pass or overtake any pace car at any time.

Any participant and/or guest of participant breaking traction and/or causing damage will risk immediate expulsion from the event and the impounding of the participant's vehicle. Participant understands and agrees that there will be zero tolerance for any activity deemed unsafe or that may be deemed to cause damage should it be allowed to continue.

Participant understands and agrees that he/she will not allow others to operate his/her vehicle in or on the track at any time. It is the Participant's sole responsibility to control his/her own vehicle and shall take full responsibility for any damage or injuries caused by another individual, whether or not Participant has given permission or has knowledge of the activity.

Participant understands and agrees that if his/her vehicle is in an accident and/or causes damage to any real or personal property, whether he/she is driving or another individual is driving with or without participant's permission or knowledge, participant's vehicle may be impounded and held until participant reimburses CBS Radio, KFRG, California Speedway Corporation, Riverside Motorcycle, Inc.
